INTRODUCTION

The desire of the Corps to meet its goals for the year started in earnest with remarkable gains made in the first and second quarters of the year

Efforts have ben put in place to sustain operational and non-operations activities that would ultimately lead to goal attainment despite the rough financial terrain

The 20% reduction in Crashes and 30% reduction in fatalities based on 2014 benchmark remains active. However, 84.3% of Total Road Crashes have been attained and the Corps is at 93% of Fatality threshold. This brightens hope of attaining 2015 corporate strategic goals

Q3(2015) ANALYSIS

ANALYSIS

The Corps recorded massive improvements in all its activities between August and September 2015. But the reverse was noted between July and August, 2015.

Comparing the Corps activities with the same period last year (2014), there was massive decline in all operations activities suggesting the impact of some of the special intervention patrols not fully felt. However, public enlightenment, vehicle and passenger travels as well as application for driver license and number plate production soared high implying that, motorization in the country may have increased.

A 3-year (2013-2015) review of the Road Traffic Crash indices show that RTCs in 2015 were higher than other years, although there were improvements over the 2014 records in terms of number of persons killed and injured. A monthly trend analysis of 2015 Crash indices indicates that apart from January, RTCs, Killed and Injured persons were on the upward trend than other months in the year.

OBSERVATIONS

The RTC indices in Q3, 2015 were higher than other years

Increase/Decrease in Motorization within the period was not taken into account when measuring performance

Special intervention patrols were few and thus minimal impact on overall performance Nasawara, Niger, FCT and Benue recorded highest number of Crashes involving Motorcycles, while Kaduna, Ogun, Kogi, Ono, and Oyo States recorded the highest number of persons killed in 2015.

RECOMMENDATIONS

Kaduna, Ogun, Kogi, Oyo and Ondo States should be specially focused on during the forth coming special Patrol. Due to the peculiarity of these States and the interconnections they have with other states as well as the number of haulage vehicles transiting these states, they should be accorded priority to drastically reduce road fatalities.

The Corps should consider the inclusion of regular traffic count every quarter to observe and note the motorization trend so as to accurately evaluate progress made by the Corps in terms of road traffic crash reduction.

The Corps organize additional special intervention patrols in the first and third quarters of the next year as they appear to be period where crashes tend to soar naturally.

The December 2015 Patrol to be given maximum attention for the Corps to attain its set goals. Motorcycle crash prevention should be accorded priority especially in States where they are predominantly used as public transport.

RECOMMENDATIONS II

The Corps should ensure that the 01 Apr 2016 speed limiter initiative is vigorously pursued to serve as enabler in making Nigeria realise the UN Decade of Action and the goal of making Nigerian roads ranks within the league of global safest highways .

The Corps should also factor in the increasing motorization in the country arising from increases in vehicles importation and assembling of motor vehicles locally in the country, to plan for increased motorisation in 2016 and beyond

The Corps should fastract the endorsement of the Nigeria Road Safety Strategy document for aiding Nigeria attain the vision of a country where road traffic crashes result in zero fatality.
