# ANALYSIS ON FREE DRIVERS TRAINING AND EDUCATED OFFENDERS FOR 4<sup>th</sup> QUARTER, YEAR 2014.

#### INTRODUCTION

Analysis on free driver training programme and Educated Offenders for 4<sup>th</sup> quarter year 2014 which include the months of October, November, and December were made base on the data received from both Training department and Corp Public Enlightenment Office. Since FRSC is saddled with the responsibility of making the roads safe for all it is relevant for us to monitor our efforts at reaching out to the members of the public which is one of the pillars of the Decade of Action via Road User Education.

### ANALYSIS

Tables and Charts were used in presentation of the analysis done on the data received from both Training Department and CPEO on Free Drivers Training and offenders educated within the period under consideration. Both Zonal and Sector analysis/comparisons were made while that of the  $3^{rd}$  and  $4^{th}$  quarters of 2014 were also compared to assess the performance of the Commands in carrying out these management directed activities.

Table 1 shows the records of commands total weekly traffic offenders educated and the weekly uploaded values. Table 2 shows the summary of educated offenders weekly received and uploaded on Zonal basis. The differences of both  $3^{rd}$  and  $4^{th}$  quarters on educated offenders are represented in table 3. In table 4, numbers of free drivers training on state basis for  $3^{rd}$  and  $4^{th}$  quarters were shown. For Table 5, summary of the percentage of free drivers training for  $4^{th}$  quarter on zonal basis were clearly spelt out.

### OBSERVATIONS AND FINDINGS

The analysis majors mainly on  $4^{th}$  quarter of the year 2014 and its comparison with the  $3^{rd}$  quarter.

- i. It was generally observed that 3 highest commands with the numbers of offenders educated are; RS2.1(Lagos), RS11.3(Ibadan) and RS9.4(Imo), while at the base of the table are RS12.3(Yobe), RS10.2(Kebbi) and RS3.1(Adamawa).
- ii. Also observed is that most of the numbers of offenders educated which were received could be uploaded totally into the FRSC Payment System Portal, except for four commands like RS2.1(Lagos), RS11.1(Osun), RS9.3(Abia), and RS7.2(Niger) while commands like RS1.4(Jigawa), 12.2(Borno) did not present any data to be uploaded.
- iii. It was observed as well that most states sent in numbers of educated offenders except for RS1.4 (Jigawa) and RS12.2 (Borno) as against that of 3<sup>rd</sup> quarter that had up to 10 commands that did not send. With this, showing signs of improvement and adhering to recommendations given in 3<sup>rd</sup> quarter report.
- iv. For free drivers training states like Ekiti, Benue and Katsina led the pack with 115, 100 and 68 drivers trained in their commands for 4<sup>th</sup> quarter of the year. It was as well observed that 19 states did not have free drivers training programme held in their commands and the list goes thus: Adamawa, Gombe, Plateau, Nasarawa, Edo, Asaba, Kogi, Ebonyin, Zamfara, Osun, Oyo, Borno, and Yobe, also included is the whole of RS1 except katsina, and the whole of RS2.
- v. Lastly, it is observed that free Drivers training and education of traffic offenders are not taken serious by some states as it is known that majority of the states listed above are not being disturbed by insurgent activities except for the very few states like Adamawa, Borno and Yobe.
- vi. It is also observed that data and reports are not always sent from the fields within the stipulated time. By this giving those that work on the data hard task in the headquarters which in the long run hamper them from meeting their targets of submitting within the deadline given by PIO office

#### RECOMMENDATIONS

- i. Commands should make it a point of duty to get the full details of offenders and drivers trained in their commands by this making those uploading them easy access to upload all data received from the field commands
- ii. Offenders should be educated on the usefulness of following the basic traffic rules which in the long run will make our roads safe for all.
- iii. On the lecture content, a structured curriculum that could be a summarized version of the Driver's Training manual should be produced as lecture materials for all the commands.
- iv. There should be better supervision of Commands by TSC and CPEO to identify those not taking the free Drivers Training serious to be charged to desist from doing such and the management to mete appropriate punishment for dereliction.
- v. Commands should also be made to understand that all these data are needed in Headquarters within the stipulated time as this may help in having proper lecture exercise for the coming month.

### CONCLUSION

The offenders lecture and the free Drivers Training Programme initiatives are strategies that will enhance attainment of the goals of FRSC .Hereby, giving FRSC the better chance and environment of inculcating into road users how best to make use of the roads. And also with the inclusion of these trainings into FRSC strategic goals for the year 2015, we believe there will be better turn up infield commands sides over that of year 2014.
